- 1- In accordance with the first item of the agenda, Prof. Dr. NERİMAN ŞAHİN GÜÇHAN, Chairman of the Provisional Board of Directors, made an opening speech and said that 29 members out of 74 members and 1 guest were present in the roll call, thus the majority was achieved.
